REVISION OF FEE STRUCTURE FOR THE AY2020-21

(31.10.2020)

In terms of the order dated 28.10.2020 passed by the Hon'ble Supreme Court read with the order dt. 13.20.2020 passed by the Hon'ble Calcutta High Court, the school has revised its fees and reduced it by further 20%. Such revised fees schedule would be as follows applicable with retrospective effect from 1st of April 2020:

Note:

1. The existing fees structure for the academic year 2020-21 were the same as those of academic year 2019-20 and in terms of the orders of the Hon'ble courts a further reduction of 20% has been made.
2. **Parents and guardians of the students are requested not to avail the reduction on the school fees if their financial situation does not merit the deduction.**
3. By November 30th, 2020, the fees payable in terms of the above schedule must be paid.
4. The school shall be entitled to disallow the students whose fees have not been paid with effect from December 8th, 2020.
