RECHECK, RE-EVALUATION, AND IMPROVEMENT EXAMINATION FOR ICSE / ISC YEAR 2025

Parents and students of the ICSE and ISC Batch 2025 are requested to kindly note the following details:

1. RECHECK OF ANSWER SCRIPTS:

- Applications for recheck can be made by candidates themselves within FOUR days
 from the date of declaration of results, either through https://cisce.org or via the Head
 of the School.
- · No applications will be accepted after the stipulated period.
- The fee payable for rechecking will be Rs. 1000 /- paper/subject.
- The results of all recheck requests will be declared together on the CISCE website: www.cisce.org.

2. RE-EVALUATION OF ANSWER SCRIPTS:

- Candidates who are not satisfied with the recheck results of the subject(s) for which
 they had applied may submit a request for re-evaluation of their answer script(s) for
 that/those subject(s) only.
- Applications must be made through https://cisce.org within THREE days of the publication of recheck results.
- The fee for re-evaluation will be Rs. 1500 /- paper/subject.

3. IMPROVEMENT EXAMINATION:

- Candidates who wish to improve their marks/grades in the same year of the
 examination may appear for the Improvement Examination in a maximum of two
 subjects.
- Online registration for the Improvement Examination will take place in June/July 2025.
- All candidates of the ICSE/ISC Year 2025 Main Examination are eligible, including those with the following results:
 - PCA Pass Certificate Awarded
 - PCNA Pass Certificate Not Awarded
- Further details regarding the Improvement Examination will be uploaded shortly on the CISCE website: https://cisce.org.

4. DATES OF THE IMPROVEMENT EXAMINATION:

 The Improvement Examination is scheduled to be conducted in July 2025, or as announced by CISCE.
